Judge Floerke serves with several teams of dedicated professionals and community members seeking to bring accountability and restoration for those in the judicial system and focuses on people struggling with addiction and mental health concerns. He trains judges and other professionals throughout Minnesota and across the nation and has received awards and commendations for his passionate efforts to work out justice effectively and with care, dignity, and respect.
